Approximately 6 million (3%) of U.S. adults engage in problem gambling each year. ## Strategic Planning for Problem Gambling Prevention

We provide consultation to the state staff responsible for the implementation of problem gambling prevention and treatment as well as state councils interested in creating muti-year plans.

- Conducting key informant interviews with relevant stakeholders to gather qualitative data on issues, barriers, and potential solutions
- Facilitated strengths and gaps analyses to identify unmet problem gambling needs, the impact
  of gambling prevention efforts, and changes in the gambling prevention landscape
- Facilitated virtual or onsite meetings based on the scope, goals, and size of the planning teams, we can design and facilitate a multi-session planning process
- Creating a written plan that can inform partners and guide the implementation of the plan
